PA MANDATORY BACKGROUND CHECK PROCEDURES*

The Commonwealth of PA has instituted a variety of new laws that require individuals that have direct contact with children to undergo **background clearances and an abuse orientation course**.

All Employees, Volunteers and Docents at Woodmere must comply with new PA laws pertaining to background clearances for those who have direct exposure to children (under 18 years of age). Woodmere has instituted the policy that will require all Employees, Volunteers and Docents to undergo these clearances, even though it may not be direct contact, to protect the Institution.

All volunteers are required to complete the following background check procedures:

1. **PA Criminal Background Check**
2. **Child Abuse Clearance from the Dept. of Health & Human Services**
3. **Reporting Child Abuse online course via University of Pittsburgh**

Volunteers who:

1. *Have lived in the state of Pennsylvania for the entirety of the last 10 years*
AND
2. *Have never been convicted of a crime pertaining to section 6344 of state law regarding child abuse* can complete the museum affidavit form (attached) to include with clearance documents.

If the volunteer does not meet those requirements, a FBI fingerprinting clearance is required.

All of the clearances are either free of charge for the volunteer or are reimbursable, and must be **updated every three years**. The volunteer coordinator, Megan Gallagher, is available to assist you with questions or general help with the process.

Background Checks for Volunteers

- 1. PA Criminal Background Check:** www.epatch.state.pa.us
This process is simple & very quick - ensure that you check off "volunteer" so that the check is free of charge. Woodmere needs a copy of your certificate.
- 2. Child Abuse Clearance:** <https://www.compass.state.pa.us/cwis/Public/home>
Create an individual account. Once you receive a temporary password via email, login to change to a permanent password of your choosing. Once logged in, you can complete the clearance process. It requires that you have all of your address & people who've lived with you since 1975, so please have that information handy.
- 3. Reporting Course:** www.reportabusepa.pitt.edu
Click the top tab for registration and create your account. Once you receive a user ID and password, you can work through the course. It takes roughly 1-2 hours to complete, but the site will bookmark your place in the course if you wish to stop and restart.
- 4. FBI Clearance & Fingerprinting** *(Only required for specific circumstances; see above):*

Register on the website. There is a listing of multiple area locations to get fingerprints taken. Many locations do require appointments, but the process only takes about 10 minutes.

I further swear or affirm that I have never been convicted of or pled guilty to any of the following offenses: criminal homicide; aggravated assault; stalking; kidnapping; unlawful restraint; rape; statutory sexual assault; involuntary deviate sexual intercourse; sexual assault; aggravated indecent assault; indecent assault; indecent exposure; incest; concealing the death of a child; endangering the welfare of children; dealing in infant children; prostitution and related offenses; obscene and other sexual material and performances; corruption of minors; sexual abuse of children; or the attempt, solicitation, or conspiracy to commit any of the aforementioned offenses.
6. I further attest and certify that I have not been convicted of an offense designated as a felony under the Controlled Substance, Drug, Device and Cosmetic Act.
7. I further attest and certify that I have not been convicted of an out-of-state or Federal offense similar in nature to the foregoing offenses listed in Paragraphs 5 and 6 above.
